(A minor is any individual who is 17 years old or younger.)

I, _____, a minor, and my parent, do hereby give permission to The Board of Trustees of Illinois State University, to use my photograph, photographic image, and/or audio/video recording in any manner for official University business, including: University Web sites, University newsletters and newspapers, etc. I consent to my photograph, photographic and/or audio/video recording being stored with third party vendors. I understand that the use of my photograph, photographic image, and video/audio recording shall in no way be used by the Board of Trustees of Illinois State University in any other forum other than for official University business, including educational and archival purposes.

I hereby grant to The Board of Trustees of Illinois State University, its officers, employees, and agents and those acting with its authority and permission, the irrevocable and unrestricted right and permission to copyright, in its own name or otherwise, and use, re-use, publish, and re-publish photographic portraits, video recordings, or pictures of me or which I may be included, in whole or in part, or composite or distorted in character or form, without restriction as to changes or alterations, in conjunction with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium, and in any and all media now or hereafter known for illustration, promotion, art, editorial, advertising, trade, or any other purpose whatsoever. I also consent to the use of any printed matter in conjunction therewith.

I hereby waive any right that I may have to inspect or approve the finished product and the advertising copy or other matter that may be used in connection therewith or the use to which it may be applied. I hereby release, discharge, and agree to save harmless The Board of Trustees of Illinois State University, its officers, employees, and agents, and all persons acting under its permission or authority or those for whom acting from any and all liability including by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.

I do hereby release, acquit and forever discharge the Board of Trustees of Illinois State University, its officers, employees, attorneys, representatives, insurers, agents and assigns from any and all demands, causes of action and/or judgments of whatsoever nature of character, past or future, known or unknown, whether in contract or in tort, whether for personal injuries, property damage, payments, fees, expenses, accounts receivable, credit, refunds, or any other monies due or to become due, or damages of any kind or nature, and whether arising from common law or statute, arising out of, in any way, the use of my photograph, photographic image, or audio/video recording as outlined above.
